

**INSTRUCTION LETTER FOR THE CLAIMS PROCESS FOR CREDITORS OF
SIKH LEHAR INTERNATIONAL ORGANIZATION (“SLIO”)**

A. CLAIMS PROCESS

By Order of the Ontario Court of Justice Arrell made December 11, 2019 (the “**Claims Procedure Order**”), J.P. Graci & Associates Ltd., in its capacity as Court-Appointed Receiver has been authorized to conduct a claims process in respect of claims against SLIO (the “**Claims Process**”). A copy of the Claims Procedure Order and other related information can be obtained from the Receiver’s website at www.ipgraci.ca/sikhlehar.

This letter provides general instructions for completing a Proof of Claim form in connection with the Claims Process. Capitalized terms not defined within this instruction letter shall have the meaning ascribed thereto in the Claims Procedure Order.

The Claims Process is intended to identify and determine the amount of Claims against SLIO. Please review the Claims Procedure Order for the full terms of the Claims process. If you have any questions regarding the Claims Process, please consult the website of the Court-Appointed Receiver provided above, or contact the Receiver at the address provided below.

B. FOR CREDITORS SUBMITTING A PROOF OF CLAIM

If you believe that you have a Claim against SLIO, you must file a Proof of Claim with the Receiver. The Proof of Claim must be received by the Receiver by 4:00 **p.m. Eastern Standard Time December 20 2019, the Claims Bar Date.** It is your responsibility to ensure that the Receiver receives your Proof of Claim by the above-noted date and time.

IF YOU DO NOT FILE A PROOF OF CLAIM IN RESPECT OF ANY SUCH CLAIMS BY THE CLAIMS BAR DATE, YOUR CLAIMS SHALL BE FOREVER EXTINGUISHED AND BARRED.

All Claims denominated in a currency other than Canadian dollars shall be converted by the Receiver to Canadian dollars at the Bank of Canada noon spot rate as at the Claims Bar Date.
